




10 Serving Homeless Families

ENERGY ASSISTANCE

Beat the Chill, Help Your Budget: Apply for Energy Assistance

The Minnesota Energy Assistance Program provides financial assistance to households to help pay a portion of their home energy bills.

Grants are based on household size, income, fuel type, and energy usage. Primary Heat grants are sent directly to the household's energy vendors to assist households' ability to maintain affordable and continuous energy.

Crisis assistance and Furnace Repair or Replacement is also available to approved households in need of additional help.

EAP eligible households with a delinquent water bill or disconnection from water service may be eligible to receive water crisis assistance if funding is available.

SUPPORTIVE HOUSING



121 households **obtained** safe and affordable housing

187 households **received** help paying a rental deposit

117 households **maintained** safe and affordable housing

43 households **avoided** eviction

21 households **were placed in** transitional housing

12 Households **averted** mortgage foreclosure



BI-CAP's Supportive Housing Program consists of **over 14 programs utilizing a variety of funding sources** including Department of Housing and Urban Development, MN Housing, and MN Department of Human Services.

Supportive Housing services range from one-time assistance to on-going case management and rental subsidies.

Find Stability, Build a Future: Get Help with BI-CAP's Housing & Support Services BI-CAP's programs typically serve those that are already homeless and are in the greatest need of housing support services. BI-CAP utilizes the "housing first" strategy of rapidly rehousing participants to mitigate crisis situations and then provides support services to assist participants as they work on housing stability and selfsufficiency goals.

WEATHERIZATION

BI-CAP's Weatherization department works with clients to improve a home's energy efficiency and health and safety while decreasing the energy consumption. Priority is given to elderly, disabled, households with high energy consumption and single head of households with children.





\$761,000 was spent at 107 client's homes focusing on insulation, air leaks, ventilation and health and safety related items.



\$981,000 was spent on upgrading clients heating systems.

- 124 families received a high-efficiency furnace
- 27 families had their systems repaired



\$72,000 spent on general repairs to mechanical systems and home structures.

Weatherization identifies areas of the home that are losing the largest amount of heat. Air sealing gaps and cracks in the attic floor can reduce a home's heat loss by 40%.



YOUTHBUILD


Since 1989, BI-CAP YouthBuild has constructed and rehabilitated over 26 single-family homes, two Head Start facilities, helped maintain 11 transitional housing properties, and assisted in the construction of a 22 unit subdivision in the community of Blackduck.

Participants began constructing exterior and interior walls on their new project on 120 Gould Avenue in Bemidji. Once completed, this will be a 3 bedroom/2 bathroom home on a heated slab, with an attached garage.

Industry-Recognized Credentials: Youthbuilders receive certification in NCCER (National Center for Construction Education and Research), OSHA 10/30, First Aid/CPR, Certified Nursing Assistant, and other certifications of choice.





Isabell

Isabell enrolled in the program as a single mother full of determination. She graduated with her diploma, completed CPR 1st Aid, and was eager to move on to the next step. She enrolled into Leech Lake Tribal College for Psychology as a part-time student and was in a paid internship position through a local radio station.



Josiah

Despite his young age and life barriers outside of the program, Josiah proved to be a reliable and dedicated worker. He completed NCCER, CPR 1st Aid, and OSHA 10 certifications and attained his driver's permit while in the program. Josiah also earned extended program time for his many weeks of perfect attendance and hard work in school and on the jobsite. He completed his credits for graduation early and is looking to move into a job in construction.

DID YOU KNOW ?


Participants receive school credit toward graduation for all activities through our educational partner, Cass Lake-Bena School District's Alternative Learning Center.

The school district provides a teacher to be available year-round, five days a week, to teach in our YB Training Center classroom.

Along with Cass County Adult Basic Education, the partnership allows participants the ability to work toward a high school Diploma, GED, or Adult Diploma.


